Dear Village at Oasis Owner,

The Village at Oasis Annual Meeting is scheduled for Thursday, February 5, 2026. In accordance with Senate Bill 323 (an act that amends Civil Code §5105(c) and §5105(e)) a Call for Candidate notice must be posted thirty days prior to candidate submission deadline. Please refer to the Association Election Rules to determine your eligibility for board candidacy. Ensure that you include a brief resume (not to exceed one page) of your qualifications. A self-nomination form can be downloaded from the website and copies are also available at the front desk in the club house. Your form and resume will be included in the Annual Meeting notice that is mailed to each owner a minimum of thirty days prior to the scheduled meeting date.

There are three (2) Board positions, currently held by Kathryn Dodds and Terry Durst, which will be available. Please be advised that you must notify the Association, no later than 5:00 p.m. PST on Monday, November 17, 2025, of your desire to run for the board of directors. You must do so by signing the Self Nomination Statement below and returning it to the Association by hand delivery or mail to: Village at Oasis Homeowners Association, c/o Resort Manager, 4190 East Palm Canyon Drive, Palm Springs, CA 92264.

Please be further advised that only Members that meet the eligibility requirements set forth in the Association's Election Rules shall be entitled to run for the board of directors. A member's qualifications shall be determined as of the record date established by the Board, which is the date 30-days prior to the day the election materials are sent out by the Association. Any potential candidate has the right to participate in IDR with the Association if the potential candidate is subject to disqualification (CC §5105) as defined in the Associations Election Rules.
